Registration and participation

- 1. You enter the TCS London Marathon entirely at your own risk and Anthony Nolan shall not be liable for any injury or loss which you may suffer or incur as a result of your participation in this event, unless such injury or loss is incurred as a result of Anthony Nolan's negligence.

Fundraising
