

**Terms and Conditions of Ballot entry in the 2026 TCS London Marathon
TCS London Marathon, Sunday 26 April 2026 (the “Event”)**

Registration and participation

1. You enter the TCS London Marathon entirely at your own risk and Anthony Nolan shall not be liable for any injury or loss which you may suffer or incur as a result of your participation in this event, unless such injury or loss is incurred as a result of Anthony Nolan’s negligence.
2. I will inform Anthony Nolan Events Team immediately if I am unable to take part in the Event.

Fundraising target

3. I pledge to raise as much as I can for Anthony Nolan through my participation in the Event.

Donations and payment terms

4. I will keep details of the names and addresses of, and amounts donated or pledged by, all donors and provide such details to Anthony Nolan on request.

Fundraising

7. I will comply with any fundraising guidance or advice issued by Anthony Nolan.
8. I will collect money only on behalf of Anthony Nolan in connection with the Event.
9. I will use only lawful means to fundraise for Anthony Nolan and will not do anything that harms or is likely to harm the Anthony Nolan reputation.
10. I will not use the Anthony Nolan's logo without permission and will obtain all fundraising materials from Anthony Nolan.
11. My fundraising **will not** include:
- a. Raising funds by carrying out door-to-door or unsolicited collections;
 - b. Collecting in any public place without first obtaining authorisation from the local authority and any other licences or consent that Anthony Nolan require me to obtain
 - c. Collecting on private property (including shops, pubs etc) without first obtaining permission of the owner of the private property.
 - d. Conducting any raffle or lottery or putting on any public Event without first contacting Anthony Nolan and taking any steps which Anthony Nolan require.
12. I agree that Gift Aid payments cannot count towards the fundraising pledge and instead will be considered as over and above the pledged fundraising total.
13. I agree that Anthony Nolan can terminate my authority to fundraise on their behalf at any time by sending written notice to the address above.

Personal data and images

14. I give permission for the free use of my name, picture, image, feedback and comments in any future publicity, advertising, fundraising materials and/or promotion.
15. I give permission for my personal information to be stored and used by Anthony Nolan in connection with the organisation, promotion and administration of the Event.

Health, safety and fitness

16. I take part in the Event at my own risk and will not hold Anthony Nolan or any connected persons responsible for any accident, injury or illness sustained to the fullest extent possible in law.
17. I will fully prepare myself for the physical challenge of the Event and I will check with my doctor to ensure that I am medically fit to participate in the Event.
18. I will comply with any health and safety and other rules or guidelines issued by Anthony Nolan or any Event organisers.

Dates, changes and termination

19. This agreement will be valid from the date on which I sign until 26 June 2026, unless terminated earlier by Anthony Nolan.
20. Anthony Nolan may vary or terminate this agreement by giving written notice to you.
